1. ASSUMPTION OF RISK.

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH PARTICIPATING IN THESE RIDES, AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THERE FROM. I AGREE TO FOLLOW THE INSTRUCTIONS GIVEN BY Yelagiri WILDZONE IN OPERATING THE EQUIPMENT. HOWEVER, I AM NOT RELYING ON ANY OF Yelagiri WILDZONE TRAINING OR OTHER INFORMATION OR PROMISES BY Yelagiri WILDZONE OTHER THAN WHAT IS IN THIS AGREEMENT IN DECIDING TO PARTICIPATE IN THESE ACTIVITIES OR IN SIGNING THIS AGREEMENT.

2. RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT.

A. I AGREE TO WAIVE ANY AND ALL CLAIMS OF ANY KIND that I have or may in the future have, whether directly or by subrogation or otherwise, against Yelagiri WILDZONE (or any of its affiliates, employees, proprietor, collectively, "Yelagiri WILDZONE") and TO RELEASE Yelagiri WILDZONE from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer resulting from my participation in the ride *DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE ON THE PART OF Yelagiri WILDZONE, OR THIRD PARTIES AND ALSO INCLUDING THE FAILURE ON THE PART OF Yelagiri WILDZONE TO TRAIN ME OR SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE.*

B. I AGREE TO HOLD HARMLESS AND INDEMNIFY Yelagiri WILDZONE from any and all liability for any damage to property or personal injury to any third party, resulting from my participation in the rides.

C. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and representatives, in the event of my death or incapacity.

D. I expressly waive any benefits I may have under any law, that provides that a general release does not extend to claims with I do not know or suspect exist in my favour at the time of execution of this release, with if known by me must have materially affected my decision to sign this Agreement.

E. I undertake, during the time I shall have the Yelagiri WILDZONE equipment under my possession, to respect and comply with all rules and regulations governing the use of the Yelagiri WILDZONE equipment, to safely ride, not to ride under the influence of alcohol, drugs or anything that could impair my actions.

F. Any litigation between Yelagiri WILDZONE and me relating to the adventure ride or this Agreement (whether arising under this Agreement or any statute, regulation, ordinance, or other rule of law or otherwise) shall be solely and finally settled by arbitration in Indian Arbitration Act.

G. I HAVE READ AND UNDERSTOOD THIS AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST Yelagiri WILDZONE

3. I agree to pay a minimum of **Rs.5000.00** or as estimated by **WILDZONE** for any damages caused by me to the vehicle due to rash driving, toppling of vehicle, hitting against rocks etc. on the track
